MCCPTA 2021 Resolution on School Resource Officers and School Safety and Security

How does a Resolution come before the MCCPTA Delegates for adoption?

- There are several ways (outlined in the MCCPTA "standing rules"). This particular Resolution came out of the Diversity, Equity, and Inclusion (DEI) Committee.
 - o MCCPTA Board of Directors approved the DEI to present to the Delegates at the January Meeting;
 - o At the January Delegates Assembly, the DEI presented their research and recommendations and made a *motion to consider adoption of* a new 2021 SRO resolution and a *motion to* consider rescinding the 2010 SRO Resolution.
 - The Delegates approved the motions and, in doing so, accepted the "task" to discuss these times with local PT(S)A units so they would know how to vote when this was brought to a vote.
 - At the March Delegates Assembly, the DEI Committee made a motion to adopt the 2021 SRO Resolution and at the Continuance Meeting, made a *motion to rescind* the 2010 SRO Resolution.

How do amendments work?

- As part of the process outlined, after the DEI committee presented their proposed resolution, the DEI committee invited amendments to be sent in advance of the March Delegates Assembly.
- The committee considered items sent by March 18th and incorporated many suggestions. strengthening the language of the original resolution (aiming to minimize time spent on minor language changes).
- When the DEI made a motion to adopt the resolution, now making it a matter before the Delegates, , the Delegates then had another opportunity to make amendments from the floor.
 - o At this point, if there were amendments sent forward that were not incorporated by the committee, this was the time to make the appeal to the full body of Delegates to incorporate.

Why was the debate stopped while there were Delegates that still wanted amendments to be considered?

As part of the process, the Delegates agree to a timeframe to debate the motion. The Delegates may extend the time (by 2/3 vote to approve). In this case, there was a motion to extend time and it failed. A vote took place at the expiration of time on the clock.

What was the vote* on the motion to adopt the 2021 Resolution on School Resource Officers and School Safety and Security?

• PASSED – 100 voted in favor of passing (61%); 65 voted opposed to passing (39%)

What was the vote* on the motion to rescind the 2010 Resolution of School Resource Officers?

• PASSED – 100 voted in favor of rescinding (64%); 54 voted opposed to rescinding (36%)
